

Financial Plan of New Venture By Prof G.Krishna Murthy



A Brief Note on the Proceedings of the Seminar on:

Financial Plan of New Ventures conducted by Prof. G. Krishna Murthy on February 12, 2019..

Most of the potential entrepreneurs feel to think that their immediate problem is fund

raising. They are always worried about the size of the investment required. They are much worried about these two problems and end in mental anguish. Then the final result is total withdrawal from becoming an entrepreneur. Prof. Murthy has explained the basics of Financial plan. It is an estimation of long and short term capital requirements followed by the identification of the sources of funds. Long term capital is necessary for acquiring infrastructure required for running the business. For carrying on the routine business operations current capital is required. Depending upon the demand for the product in the market both the types of capital is deermined. Further, the ratio between the long and short capital is to be determined by the startup. The implementation of the Financial Plan is the next step that has to be attempted. There are many agencies that supply the long term funds like development banks, and commercial banks. The Startup has to decide the best source in terms of cost of capital. Short time capital is meant to buy the current assets and to meet the short term financial commitments like power, wages, buying of raw-materials etc. The participants wanted to have a practical exercise on the preparation of Financial Plan. To satisfy the needs of the participants, a case study is given by Dr. Murthy to them and analysed it. The participants are made to understand the forecasting of the demand for the product/service on which basis the plant and machinery installation is planned. This forecast is done not only for the present time but also for future. This is the prerequisite to determine the total funds required. After editing and checking of the estimations the participants expressed their gratitude
