

And the terms of MOU are addressed hereunder.

1. The first party is willing to provide guidance for execution of Mini project work for the B.Tech., MECHANICAL ENGINEERING students of 2016-20 batch., as part of their academic requirement.
 2. The first party shall provide project guidance to the students at second party premises on commercial terms and conditions, which is Rs.3500/- (Fifteen Hundred Rupees Only) per student for Mini Project execution.
 3. Each batch must consist of 5 students. Minimum number of batches should be 15 for each course. Components, software, hardware and such other things shall be procured by the Second party or Students.
 4. This Mini project will be on DESIGN, ANALYSIS AND FABRICATION for the students which are the part of their academic requirement. The project list will be provided by first party.
 5. The first party will complete all the projects within 15 working days; the time frame depends on attendance of the students at second party's premises. Second party will ensure all the students attend the project work in the given period.
 6. The first party is willing to start the MINI project work for students from 06 June 2018 at second party premises.
 7. Payments should be made by the second party to first party in the following modes:
 - a. 50% of the total payment – After 7days of the project start date
 - b. Rest of 50% of the total payment – After completion of the Mini project execution.
 8. The first party is strictly prohibited from involving any financial transactions directly with the students.
