3. STRUCTURE OF PROGRAMS

The MoU is planned to provide a platform to TCS, to offer the EEE related courses, projects and provide necessary guidance.

3.1 CONDUCTING EEE RELATED COURSES/PROJECTS

TCS will identify and provide EEE Related Internships/ Mini projects/Major projects and various courses at company/college. TCS will also identify the resources required along with timeframes for the completion of the Internships and projects. TCS will identify suitable internship and project coordinators/mentors and depute them as required. The project coordinators will guide the students/staff in all phases of the Internships and projects.

TCS will conduct an evaluation on completion of the internships/ projects/courses which will include presentation and Viva Voice for students.

TCS to comply with and strictly adhere to IEEE guidelines in all the phases of internship/project development and should incorporate and implement the same in the Internship/Project reports also.

TCS will provide certification for the students who complete the internship /projects/courses successfully, and certificates will be issued through the Head, Dept of EEE, JITS.

TCS will provide projects related components and PCB boards to the students. Modules also provides for the execution of the project.

JITS will provide infrastructure facilities (i.e. H/W,S/W, etc) for conducting the above when initiated at college premises.

JITS will identify coordinators for the internships/projects along with the teams of students.

The coordinators will finalize with TCS in aspects of the internships/ projects.

3.2 Joint responsibility of TCS and JITS

TCS and JITS will mutually decide the internship/project titles, scope of work, duration, resources required and other modalities before the commencement of the programs.

3.3 Confidentiality

Both the parties agree to maintain confidentiality of information and the information can be released only with mutual agreement. All the IP cores supplied by TCS are proprietary to TCS, JITS will use them only for purpose only.

3.4 Validity of the MOU

This arrangement shall remain in force for a period of two years from the date of signing thereof and be automatically renewed for successive period of one year and can be terminated by giving a written notice period of three months by either party.

4. FORCE MAJEURE




